STANDARD WARRANTY

All JP Power Technology Inc. equipment has been thoroughly tested and found to be in proper operating condition upon shipment from the factory and is guaranteed to be free from any defect in workmanship for a period of one year from date of shipment.

Any part or parts of the equipment that prove defective after examination, within the warranty period, shall be repaired or replaced without charge at the factory, or at a factory approved warranty dealer, providing such defect, in our opinion, is due to faulty material or workmanship and not caused by tampering, abuse or misapplication. All replacements are made F.O.B. JP Power Technology Inc., Edmonton, Alberta, Canada or a factory approved warranty dealer shop.

Should a piece of equipment require replacement or repair, it can be handled in one of two ways:

1. The equipment may be returned, shipping charges prepaid, to the Edmonton factory or a factory approved warranty dealer shop, to have the inspection, adjustments and/or repairs and testing performed by factory-approved personnel. Authorization, from JP Power Technology Inc. or one of its warranty representatives, must be obtained prior to returning a piece of equipment or parts to the factory. If it is found upon inspection that the defect was due to faulty material or workmanship, all repairs will be made at no cost to the customer. A purchase order to cover the cost of service must be issued prior to commencement of adjustments and/or repairs. Repaired equipment will be returned to the user, shipping charges collect.
2. If the purchaser wishes, a factory approved service representative can be dispatched to make adjustments and/or repairs at the equipment location. Reasonable travel expenses within a travel distance of 100 Km will be covered under this warranty. (Not applicable to portable equipment) A purchase order to cover the cost of service must be issued prior to the dispatch of the service technician. Adjustments and/or repairs not deemed warrantable will be charged at prevailing field service rates.

Unless otherwise covered in the contract, the purchaser, in accepting delivery of the equipment, assumes full responsibility for proper installation, installation adjustments and service arrangements.

In no event shall JP Power Technology Inc. have any liability for consequential damages, or for loss, damage or expenses directly or indirectly arising from the use of the products, or any inability to use them either separately or in combination with other equipment or materials, or from any other cause. In addition, any alteration of JP Power Technology Inc. products renders this warranty null and void.

JP Power Technology Inc. reserves the right to make revisions to the current design or construction of equipment, and assumes no obligation to incorporate these revisions into earlier models.

The failure of JP Power Technology Inc. to object to provisions contained in Customers' Purchase Orders or other communications shall not be deemed a waiver of the terms or conditions hereof, nor acceptance of such provisions.

The above warranty supersedes and is in lieu of all other warranties, expressed or implied, and no person, agent or dealer is authorized to give any warranties on behalf of JP Power Technology Inc., nor to assume for JP Power Technology Inc. any other liability in connection with any of its products unless made in writing and signed by an official of JP Power Technology Inc.
